PUBLIC NOTICE
FAMILY EDUCATION
RIGHTS AND PRIVACY ACT

The Kiamichi Technology Center School District No. 7 (KTC) has developed policies and procedures designed to meet the provisions of the Family Education Rights and Privacy Act (FERPA). Copies of district policies are available for review in the office of the Superintendent.

The district will provide to parents and eligible students an annual notice of their rights under this policy. These rights are as follows:

1. The rights of a student's parents and eligible students to inspect and review the student's education records.

2. The intent of the Kiamichi Technology Center to limit the disclosure of information contained in a student's education records except: (1) by the prior written consent of the student's parent or the eligible student, (2) as directory information, or, (3) under certain limited circumstances/as permitted by the FERPA.

3. The right of a student's parent or an eligible student to seek to correct parts of the student's education record which he or she believes to be inaccurate, misleading, or in violation of student rights.

4. The right of any person to file a complaint with the U.S. Department of Education, and the Oklahoma Department of Career & Technology Education if the Kiamichi Technology Center violates FERPA.

5. Parents and eligible students should come to the Director's office to obtain copies of the policy and information as to the correct procedure to follow in requesting action about a student's record. Copies of this policy are located in the Director's office in Atoka, Durant, Tahleah, Spiro, McAlester, Stigler, Hugo, Idabel, Poteau and the Superintendent's office in Wilburton.

The district will arrange to provide translations of this notice to non-English speaking parents or eligible students in their native language. This request may be made at any Director's office or at the Superintendent's office.

Agency will provide resources and referrals for parents Oklahoma parents can now access a statewide program designed to provide resources and referrals for services across Oklahoma.

This will allow us to help parents all across our state identify quality child care options in their area as well as resources like educational activities for their children."
